called *Cooper v. Telmate, LLC*, Case No. 1:24-cv-01622. The Litigation is about a data breach in which unauthorized third-party actors accessed the Defendant's computer network between August 13, 2020 and August 13, 2020 (the "Security Incident"), compromising the Personal Information of individuals who used Telmate's services. On September 13, 2024, Plaintiff Amber Cooper filed this lawsuit, asserting claims individually and on behalf of a putative nationwide class of people whom the Security Incident impacted. Telmate disputes the claims and allegations in the Litigation, any and all liability or wrongdoing of any kind to the Class Representative, the Settlement Class, and any other individuals or putative class members described in the pleadings, and further denies any violation of law whatsoever as described in the pleadings.

Am I included? The Defendant's records identify you as a Settlement Class Member. The Settlement Class consists of all individuals within the United States of America whose Personal Information was impacted during the Security Incident experienced by Defendant on approximately August 13, 2020.

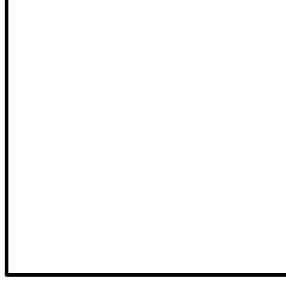
What does the Settlement provide? Under the proposed Settlement, the Defendant will pay \$4,225,000 into a Settlement Fund to resolve the Litigation. The Settlement Fund will provide cash payments to Settlement Class Members as well as the Costs of Settlement Administration, the Attorneys' Fee Award and Court-approved Cost Reimbursement, and the Service Award. Settlement Class Members may file a claim for a Pro Rata Cash Payment and, in addition, may seek reimbursement of up to \$5,000 for Documented Out-of-Pocket Losses more likely than not attributable to the Security Incident.

How do I get Settlement Benefits? You must file a Claim Form online on the Settlement Website at www.telmedatabreachsettlement.com or by mail to the address on the Claim Form postmarked by **Month XX, 2026**. The Claim Form is available on the Settlement Website or by calling **(XXX) XXX-XXXX**.

What are my other options? If you do nothing, you will not receive a Settlement Payment, you will remain in the Settlement, and you will give up your rights to sue the Defendant for the claims resolved by this Settlement. If you do not want a Settlement Payment, but you want to keep your right to sue the Defendant for the claims resolved by this Settlement you must exclude yourself from the Settlement Class (called "opting out"). If you do not opt out, you may object to the Settlement and ask the Court for permission to speak at the Final Approval Hearing. The Opt-Out and Objection Date is **Month XX, 2026**.

The Court's Final Approval Hearing. The Court will hold a hearing on **Month XX, 2026** at **XX:XX a.m./p.m. ET** to decide whether to approve the Settlement, up to \$1,408,333.33 in attorneys' fees, plus reimbursement of litigation costs of up to \$35,000, and a \$5,000 Service Award to the Settlement Class Representative for her efforts on behalf of the Settlement Class. You or your lawyer may attend the hearing at your own expense.
