Why am I receiving this Postcard Notice? A Settlement has been reached with United Seating and Mobility, LLC d/b/a Numotion (or Defendant) in a class action lawsuit. This Settlement involves: 1) a March 2024 Data Incident in which an unauthorized individual accessed certain of Defendant's systems, which may have included Private Information belonging to Defendant's former and current customers and employees; and 2) a September 2024 Data Incident in which an unauthorized individual accessed certain user accounts within Defendant's environment, in which the personal health information may have been impacted. Defendant denies any liability or wrongdoing, and the Court has not decided that Defendant did anything wrong. The Parties have agreed to settle the Actions ("Settlement") to avoid the risks, disruption, and uncertainties of continued litigation. A copy of the Settlement is available at www.website.com.

Who is included in the Settlement? The Court has defined the class as : "All living persons in the United States who received notice of the Data Incidents." Additionally, you are also a Social Security Settlement Class Member if you are a Settlement Class Member whose Social Security Number may have been involved in the Data Incidents.

What are the Settlement Benefits? If you are a Settlement Class Member, you may be able to receive the following benefits:

Cash Payment A – Documented Out-of-Pocket Losses: You may file a Claim, with supporting documentation, if you spent money or incurred losses between ____ and the Claims Deadline reasonably and fairly traceable to the Data Incidents, up to \$15,000 per Settlement Class Member.

OR

Cash Payment B – Pro Rata Cash: You may file a Claim to receive a cash payment. The Cash Payment may be subject to a *pro rata* (a legal term meaning equal share) adjustment based on the amount remaining in the Settlement Fund.

AND

Credit Monitoring: In addition to the Settlement Benefits above, all Settlement Class Members will be automatically entitled to receive two (2) years of CyEx Identity Defense Plus ("Credit Monitoring").

Social Security Class Members: If you are a Social Security Class Member, you may submit a Claim for two (2) years of CyEx Medical Shield Pro ("Medical Monitoring").

How do I submit a Claim Form for a Settlement Class Member Benefit? You must submit a Claim Form, available at [here] to be eligible to receive a Cash Payment. Your completed Claim Form must be submitted online or mailed to the Settlement Administrator at Numotion Data Incide nts Settlement, c/o Kroll Settlement Administration, LLC, P.O. Box XXXX, New York, NY 10150-XXXX and postmarked, by DATE. You will need the Class Member ID located on the front of this notice to submit a Claim. **TO RECEIVE AN ELECTRONIC OR ACH PAYMENT FOR YOUR VALID CLAIM, YOU MUST FILE A CLAIM FORM ONLINE AT WWW.WEBSITE.COM.**

What are my other options? If you **Do Nothing**, you will automatically receive Credit Monitoring, you will be legally bound by the terms of the Settlement, you will not receive any Cash Payment, and you will release your claims against Defendant and other Released Parties as defined in the Settlement Agreement. You may **Opt-Out** of the Settlement by <>**Opt-Out Deadline**>> or file an Objection to the Settlement by <>**Objection Deadline**>>. The Court's Final Approval Hearing. The Court is scheduled to hold a Final Approval Hearing on **DATE at TIME CST**, to consider whether to approve the Settlement, the attorneys' fees and costs, and Service Awards to the Class Representatives. You may appear at the hearing, either yourself or through an attorney hired by you, but you don't have to.
