**NOTICE OF CLASS ACTION LAWSUIT

- If you received an unsolicited prerecorded voice message from Mosquito Squad from April 1, 2019 to the present, you may be entitled to benefits under a class action settlement.
- Plaintiff claims that these messages were improper. The court has not decided who is right or wrong. Instead the parties have agreed to settle the case to avoid the risk and cost associated with further litigation.
- Eligible class members who submit a valid claim form will a payment from the \$765,000 settlement fund.

**What is this?** This is a notice of a proposed settlement in a class action lawsuit, *Samuel Lenorowitz v. Mosquito Squad of Fairfield and Westchester County*, U.S.D.C., District of Connecticut, Case No. 3:20-cv-01922-OAW. This notice explains your legal rights.

**What is this lawsuit about?** The lawsuit alleges that Mosquito Squad violated the Telephone Consumer Protection Act by sending unsolicited telemarketing prerecorded voice messages to the Class Members's cellular and/or residential landline telephone numbers. Mosquito Squad has denied all wrongdoing. The Court has not ruled on the merits of Plaintiff's claims or Mosquito Squad's defenses.

**Why am I getting this notice?** You were identified as someone who may be a member of this Settlement Class.

**What does the settlement provide?** Mosquito Squad has agreed to create a Settlement Fund of \$765,000. The Settlement Fund will pay cash to class members who could be identified by Defendant's records and fill out a timely valid claim on a pro rata basis after class counsel's fees and litigation expenses are paid (subject to Court's approval), a service award of up to \$10,000 to plaintiff is paid (subject to Court's approval), and settlement administration costs are paid.

**Can I receive a benefit from the settlement?** Yes, if you are a member of the Settlement Class. Each Class Member who submits a valid and timely Claim Form will receive either the cash or voucher award discussed above, depending on what the Class Member chooses. No Class Member will receive more than \$3,000 as a result of the Settlement.

**How do I receive my benefit?** You must complete and submit a valid Claim Form by \_\_\_\_\_. The Claim Form is enclosed and available at \_\_\_\_\_ or by calling \_\_\_\_\_. You can submit your Claim Form by mailing it to the address below or online at \_\_\_\_\_.

**Do I have to be included in the settlement?** If you don't want to receive money from this settlement and you want to keep the right to sue or continue to sue Mosquito Squad of Fairfield and Westchester County on your own, then you must exclude yourself from the settlement. You will not get any money if you exclude yourself. The Court will exclude any class member who properly requests exclusion, which is done by sending a letter requesting exclusion to the Settlement

**If I don't like something about the Settlement, how do I tell the Court?** If you don't exclude yourself from the Settlement, you can object to any part of the Settlement. You must mail your written objection to the Court, Class Counsel and Mosquito Squad's counsel by \_\_\_\_\_. You may enter an appearance through an attorney if you wish, but you do not have to. Complete details about how to object are on the Settlement Website.

**What if I do nothing?** You will not be eligible for a payment. All Class Members who do not opt out will be bound by the Settlement and the decisions of the Court, and will release Mosquito Squad from liability for the texts.

**When is the Final Approval Hearing?** The Court will hold a hearing in this case to consider whether to approve the Settlement on \_\_\_\_\_, at \_\_\_\_\_, United States District Court, 450 Main Street, Hartford, Connecticut 06103. You may go to the hearing, but you do not have to.

**How do I get more information about the settlement?** This notice contains limited information about the Settlement.
