TO OPT OUT OR OBJECT

If you don't want any benefits from or to be legally bound by the Settlement, you must submit a Request for Exclusion by mail or online at www.KetoPillSettlement.com by November 18, 2025. You may exclude yourself from the Class by [\[A3\]](#)^[A4][\[A5\]](#) sending a written Request for Exclusion to Sihler v Global E-Trading LLC, c/o Kroll Settlement Administration LLC, P.O. Box 225391, New York, NY 10150-5391 that is **received no later than the Opt-Out Date**. The Request for Exclusion must be personally signed by the you and contain a statement that indicates your desire to be excluded from the Class. Information about how to request to be

excluded is available at www.KetoPillSettlement.com. If you exclude yourself, then you cannot receive any benefits, but you do not release any potential rights to sue the Defendant relating to the legal claim in the lawsuit. You may also write to the Court if you wish to object to the Settlement by November 18, 2025. Details about what you must include in your written objection are available at www.KetoPillSettlement.com.

The Court will hold a hearing on December 2, 2025. At that hearing, the Court will consider whether to approve the Settlement and whether to approve requested Attorneys' Fees plus reimbursement of costs and requested Class Representatives' Service Awards. You may appear at the hearing, but you don't have to. The Court has appointed attorneys from the law firm Kneupper & Covey PC to represent the Class ("Class Counsel"). You will not be charged for these lawyers. If you want your own lawyer, you may hire one at your expense.
